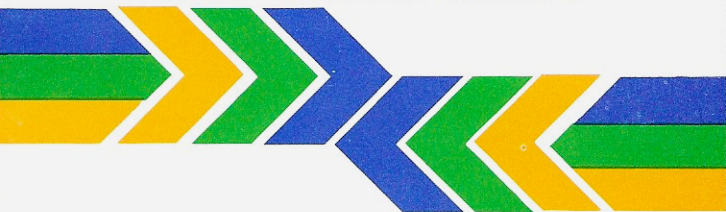

IMPORTANT INFORMATION

Check-in Times for Flights—In the interest of on-time service to all passengers, Big Sky Airlines requests that passengers be at the airport counter 20 minutes prior to published departure time. Reservations not claimed ten minutes prior to scheduled flights are subject to cancellation.

Re-Confirmation—Please re-confirm your reservation after a stopover of more than 12 hours. Re-confirmation is necessary at least 6 hours before departure in order to assure your reservations.

Baggage Identification—Mandatory—Big Sky Airlines will not accept a passenger's baggage unless the passenger's name is on the outside of such baggage. Big Sky Airlines will make baggage identification labels available at no cost to the passenger.

Baggage—The maximum free baggage allowance for a fare paying passenger will be three (3) pieces, total weight not to exceed 50 lbs. and the following dimensions:

1st piece—62 dimensional inches (length + width + height)

2nd piece—55 dimensional inches (length + width + height)

** 3rd piece—45 dimensional inches (length + width + height)

** The 3rd piece may be checked or carried on board the aircraft, provided however the bag does not exceed the maximum dimensional limit of 45 inches, and is included in the maximum weight allowance of 50 lbs. **Military Personnel** may check one (1) duffel, sea or B-4 bag in lieu of the 1st and 2nd piece. **Sporting Equipment**—Skis, golf bag, etc. are included in the per piece rules (except bicycles) **Bicycles**—\$10.00 additional charge. **Excess Baggage Charges**—When the size, weight or number of pieces exceed Big Sky Airlines maximum allowance, excess charges of \$5.00 per bag will apply. When the size, weight or number of pieces exceed the maximum free baggage allowance on Big Sky and another carrier, the excess charges are based on the one way fare and the per piece cost is; \$25.00 or under—\$4.00, \$25.01 to \$50.00—\$5.00, \$50.01 to \$120.00—\$6.00, \$120.01 to \$200.00—\$7.00, \$200.01 or over—\$8.00. **Animals**—Charges for an animal in a container will be double the applicable excess baggage charge. **Liability**—Big Sky Airlines liability for damage to, or loss of baggage is limited to \$500.00 per fare paying passenger unless a higher valuation is declared and additional charges paid in advance. If a higher value is declared over the above limit of liability, the higher value will be assessed at \$0.10 per \$100.00.

Carrier is not liable for loss, damage to, or delay in the delivery of fragile or perishable articles, money, jewelry, silverware, negotiable papers, securities or other valuables, business documents or samples or articles not suitable or suitably packed for transportation in the aircraft, which are included in the passenger's checked baggage whether with or without the knowledge of the Carrier.

RESTRICTED ARTICLES—Articles such as flammable liquids, corrosives, acids, compressed gasses, matches or other hazardous articles must not be placed in baggage. (In addition, Federal Aviation Regulations limit the carriage of compressed gasses in aerosol cans, such as hair sprays, shaving cream, and deodorants, to 32 ounces per passenger with a maximum of 16 ounces per container.) "Visible Fluid" lighters may not be used on board aircraft. AM and FM radios, TV receiver and other electronic devices must not be used on board aircraft in order to avoid disturbance of the aircraft's electronic navigational equipment. Portable electronic devices such as voice recorders, hearing aids, heart pacemakers and electric shavers will be permitted.

Equipment— 19 seat Jet Prop (pressurized) aircraft.

Responsibility—Big Sky Airlines will not be responsible for consequences arising from delays or from errors in the printed schedule. The times shown are subject to change without notice.
