## SAFETY INFORMATION

### EXIT SEATS

Please notify a crewmember if you do not meet the following criteria or do not wish to assist in an emergency.

If you are seated in an exit seat, you may be asked to assist the crew in an emergency by performing the following functions.

- Follow oral instructions and hand signals given by the crew.
- Locate the emergency exit and determine if it is safe to open.
- Open the emergency exit as shown and secure the exit so it does not impede use of the exit.
- Activate the slide, if provided, pass quickly through the emergency exit, and assist others after exiting the aircraft.
- Select and follow a safe path away from the emergency exit.

No passenger may be seated in an exit seat if it is likely that he/she is unable to perform any of the functions listed above because:

- The person has insufficient mobility, strength, or dexterity in arms, hands or legs.
- The person cannot see or hear well enough to perform functions illustrated on this card.
- The person cannot verbally relate information to other passengers.
- The person is less than 15 years of age.
- The person has a condition or responsibilities such as caring for small children that might prevent him/her from performing listed functions illustrated on this card.
- The person has a condition that might cause him/her harm if he/she performs the functions illustrated on this card.






