# Mesaba Indicates Interest in Jets

## Letter of Intent Signed For 45 Brazilian Aircraft

Mesaba said in early April that, through a letter of intent between Northwest Aircraft, Inc. and Embraer-Empress Brasileira de Aeronautica S.A. (Embraer), it has secured delivery schedules and pricing for the Embraer-145, a forty- five seat jet currently being developed by the Brazilian aircraft manufacturer.

Northwest's letter of intent with Embraer, which was signed last October, calls for forty-five aircraft and would allow for deliveries to begin in 1994 if a definitive contract were to be signed for the aircraft. According to officials from the company, Mesaba worked with Northwest to sign the letter of intent with Embraer last fall. Mesaba has rights to operate up to all forty-five aircraft on its route system.

Robert D. Swenson, President and C.E.O. of Mesaba, said the Letter of Intent does not guarantee that the company will end up signing a contract for the aircraft. Rather, he said it simply protects early deliveries and favorable pricing in the event that Mesaba were to proceed with that type of aircraft.

"We have felt for some time that jet aircraft are going to be part of our long-term growth plan," he said. "This letter of intent allows us to continue analyzing both the economic and operational performance of this aircraft before signing a definitive agreement."

The aircraft, if signed for, would be leased through Northwest Aircraft, Inc., a subsidiary of NWA, Inc. Mesaba currently leases eighteen of its thirty-one aircraft through Northwest Aircraft Inc.

Though the first prototype of the Embraer-145 is not scheduled until the end of 1991, the aircraft manufacturing company already has experienced considerable interest in the regional jet. In addition to Mesaba's order, a number of other North American carriers have signed Letters of Intent for the aircraft including; Ontario Express, 16; Business Express, 20; Comair, 60; SkyWest, 20; and West Air, 60.

The Embraer-145 is a very passenger friendly aircraft. It features a full- size galley, inflight service, and wide body comfort. The aircraft will be 87.7 feet long and have a span of 73.4 feet wide.


### **Executive Letter**



Dear Employees:

During the past several years, we have made tremendous improvements in the area of employee benefits. I am pleased to say that on May 1, we are making a further enhancement with the introduction of companion passes, or "buddy passes" as they are commonly referred to.

"Buddy Passes" are passes issued to allow friends or relatives to accompany Mesaba employees or their spouses on a Mesaba





Many of you may be wondering about Mesaba's recent announcement regarding the Embraer-145, the forty-five seat jet in which we have expressed an interest. We have felt for some time that jet aircraft were in our future, and an internal study we conducted last year confirmed that we have a need for jet aircraft on our system if the economics and operating performance are right. Last October, we worked with Northwest to sign a Letter of Intent with the Manufacturer for the purchase of up to 45 of the Embraer-145 jets. The first aircraft prototype will be ready in late 1991 and we could begin taking deliveries in late 1994 or early 1995. We are in position to receive the aircraft with favorable deliveries at competitive pricing if we decide to do so. We will continue to update you with additional information as it is available.

After all of our efforts in "Operation Recharge", we are beginning to see our system-wide reliability increase, (in fact, on May 1 and 2 we flew 100 percent of our 226 scheduled flights with an 88 percent on-time rate). We are going to begin focusing much of our energy and attention now on returning to strong profitability. We can all be proud that we have developed the new Detroit system safely and that our energies and resources in "Operation Recharge" have helped strengthen reliability on our entire system. After posting a loss of more than \$250,000 during the quarter ended March 31, 1990, we now must return to profitability so that in the coming years our company will be financially poised to acquire new aircraft and make the financial investments that will ensure our continued growth. To that end, we are looking to improve efficiencies and productivity throughout the company. Your help in these efforts is greatly appreciated.

## Mesaba Reports 36% Increase in Traffic

The Company reported that it carried 69,424 passengers in March, an increase of 35.6 percent over 51,186 passengers carried last March. The company said that it flew 14.6 million revenue passenger miles during the month, a 30.6 percent increase over 11.2 million revenue passenger miles flown during the same month last year. Mesaba's load factor during the month was 50.5 percent, compared to 55.8 percent last year.

Mesaba's new service to Columbus increases the airline's frequency at Milwaukee to seven daily departures. The company currently operates from Milwaukee two daily flights to Wausau and two flights to Indianapolis - service which began on April 1, 1990.

#### **Five Year Dinner**




Mesaba currently has fifty-eight employees who have been with the company five years or more












## Personnel News Blue Cross/Blue Shield Information

Effective November 1, 1989, Blue Cross/Blue Shield of Minnesota made it possible for your Doctor (if he or she participates with BCBS) to submit your bills directly to the Blue Cross Blue Shield of your state. If your Doctor does participate, they should know where to submit the bills.

If your Doctor does participate in the plan, he/she will submit the bill to BCBS of your state and they in turn will pay your doctor.

If your Doctor does NOT participate in the plan, then you may go ahead and submit your bill DIRECTLY to BCBS of Minnesota. They in turn will reimburse you for the covered portion of the bill.

All dental claims will require a claim form. Submit your claims directly to Blue Cross Blue Shield of MN for processing.
